- EXHIBITOR AND OWNER, WHETHER OR NOT MEMBERS OF WEWASC WILL ABIDE BY THE RULES AND REGULATIONS OF THE WEWASC AND ANY OTHER RULES AND REGULATIONS APPEARING IN THE PREMIUM LIST FOR THIS EVENT.
- EXHIBITOR AND OWNER CERTIFY THAT THE ENTERED DOG IS NOT A HAZARD TO PERSONS, DOGS OR PROPERTY.
- EXHIBITOR AND OWNER ACKNOWLEDGE ALL HAZARDS PRESENTED BY THE EVENT AND THE EVENT PREMISES, INCLUDING BUT NOT LIMITED TO THE CONDITION OF THE FLOORS, STAIRWAYS, HALLS, LIGHTNING, SECURITY MEASURES OR LACK THEREOF, ELECTRICAL APPLIANCES, SHOW RINGS, PARKING AREAS AND THE PRESENCE OF UNFAMILLIAR ANIMALS AND PEOPLE; EXHIBITOR AND OWNER ASSUME THE RISK OF ANY HARM ARISING FROM THESE.
